### Sun Peaks Resort

The largest ski area in British Columbia, Canada next to Whistler, Sun Peaks Resort consists of a ski-in/ski-out alpine village close by three mountains: Tod offers two open bowls and challenging terrain; Mt. Morrisey open glades, cruising runs and black-diamond steeps; while Sundance has groomed runs, and ski-school learning area. Sundance also reigns supreme for snowboarding, boasting advanced and intermediate terrain parks, and a 100m halfpipe.

Located in the Thompson Okanagan region of BC, Sun Peaks Resort is a 45-minute drive northeast from Kamloops. Kelowna Airport (a 2.5-hour drive) offer non-stops from, Seattle. Sun Peaks is renowned for its dependable, sunny weather conditions year round. The resort has outstanding skiing and snowboarding terrain with annual snowfall 220" of powder.

In addition to downhill, the resort offers something for everyone, skating at an outdoor rink; dogsledding; sleigh rides; snowshoeing; snowmobiling; cat trax (riding on a snow cat); cat skiing and more.



**Cross-Country Skiing** on 28km of trackset groomed trails. Imagine endless, cobalt-blue skies. The steady swish of skis gliding along a freshly groomed track. The glorious silence of skis gracing a fresh carpet of snow. This is the captivating world of cross-country skiing at Sun Peaks. ### Membership Policy

In addition there are 12km of backcountry nordic trails and dedicated **snowshoe** trails. A prime place to try shoeing, Snowshoe rentals are available. Guided snowshoe tours depart daily at 1:30 p.m. •

### Accommodations

Six nights at the Sun Peaks' Crystal Forest condos in the Tryolian inspired pedestrian-friendly ski village. Just a short distance from the Village Centre, these two bedroom, two bath condos feature gas fireplaces, heated tile floors, knotty-pine woodwork throughout, locking ski equipment storage. Ski home to Crystal Forest via the Upper Village ski trail, off of Peak-A-Boo. Full kitchens, full baths, washer and dryers, and private patio decks are standard.

The final night of the trip will be at the Holiday Inn Express Kelowna (March 7 - 8)

#### REFUND POLICY

- A trip participant is eligible for a full refund of monies paid if he/she cancels prior to **December 29, 2007**. Once ticketing occurs, the participant becomes fully liable for the full amount of the trip.
- If a participant cancels between **December 30, 2007 and January 15, 2008** it is that person's responsibility to find a replacement who will pay the full cost of the trip. (The replacement can come from the waiting list, provided one develops.) If a replacement is found, the participant is entitled to a full refund less any fees necessary to effect reservation and/or name changes and as long as the reservation can be changed to the name of the replacement per contractual obligations. If a replacement is not found, any and all penalties imposed by tour operators, transportation companies, lodging, or ski facilities, due to the withdrawal by the undersigned shall be the responsibility of the undersigned.
- If a participant cancels after **January 30, 2008** and cannot find a replacement, or fails to show up for the trip, then the participant is liable for the full amount of the trip. Once a trip is completed and all financial obligations are met, any refunds made by the tour operator, transportation companies, etc for that participant will be forwarded to the participant.
- Trip cancellation insurance is made available for every trip, and Snowbound SCI advises all participants purchase in the unlikely event that one may need to cancel.
- The undersigned participant hereby agrees that, in no event shall Snowbound Ski Club bear the financial responsibility of a cancellation.
